# Strengthening democracy and its capacity to resolve global and regional issues by the power of debate

### Mission

Our increasingly fragmented and unilateral world is facing historical change and immense difficulties within the liberal international order, multilateralism-based international cooperation, and democracy itself.

The goals of The Genron NPO are to prevent further fragmentation, foster international cooperation to address shared challenges, pursue the restoration of global governance grounded in the rule of law, and contribute to peace and stability in Asia.

Our high-level dialogues and cutting-edge, private sector initiatives in Japan have consistently called for greater multilateral cooperation and global solidarity to address the mounting global polycrisis.

We have also engaged in many initiatives to

reinvigorate democracy in Japan, and to that end, it is important to create a stage for discussion – a forum that will give people a sense of ownership of the issues faced and help them find a way of addressing them. What we need in Japan today is “courageous liberalism,” and we have begun to stand up, to speak our minds, and to take the necessary actions to bring it to life.

As a non-governmental organization, we are fully committed to confronting the crises facing the international community. In doing so, we aspire to transform ourselves into a globally-recognized and independent non-profit think tank capable of fulfilling this historic mission.



In order to realize our mission goals, we are bringing together prominent leaders, policymakers, and influential experts from both Japan and abroad, as well as actively engaging civil society actors, and currently focusing our efforts on the following three areas.

### Strengthening representative democracy

We believe that democracy does not work without a strong citizenry. It is for that reason that in 2004 we began evaluating the effectiveness of government policies and assessing political party pledges made during elections to provide such information to voters. Since then, we have continued to provide a forum for open discussion of policies that will affect Japan's future.

In addition, it has been shown that the people of Japan are losing their faith in representative democracy. To combat this, we are working with other democracies on an initiative to discuss how to reform the representative democratic framework comprised of the voting system, the Diet, the media, and other elements.

### Peace and stability in Northeast Asia

The peace in Northeast Asia is currently highly unstable, driven by escalating geopolitical tensions and so-called hotspots such as Taiwan and North Korea. In addition, Japan's bilateral diplomatic relationships with China and South Korea have long been stagnant due to historical issues and territorial disputes. It was in these circumstances that The Genron NPO established the first Tokyo-Beijing Forum, which was held in Beijing in 2005. The forum was designed to serve as a platform for non-governmental efforts to engage in dialogue that would overcome the difficulties engendered by the worsening relationship between China and Japan, and it has been held every single year for the past 20 years. We have also been conducting joint public opinion polls among citizens of both countries, and as the only such opinion poll,

they have been received to high acclaim.

Building on this foundation, we established the Japan-Korea Future Dialogue in 2012. In 2020, we connected our bilateral dialogues with actors from China, South Korea, and the U.S. with the historic launch of a multilateral forum for dialogue in which the U.S. and China can also take part in working toward realizing the dream of a peaceful order in Northeast Asia. This conference represents a significant effort to review the existing crisis management framework and to explore practical pathways toward lasting peace in this region. These efforts are intended to serve as a foundational step for future inter-governmental dialogue and cooperation in the region.

### Creating a forum for advancing multilateral cooperation on global issues

As the international order becomes increasingly unstable, fragmentation and the rise of unilateralism undermines multilateral frameworks and the foundations of global governance. The world is also seeing increasing skepticism towards liberal democracy as political and social division expand. Through the annual Tokyo Conference, which was launched in 2017, The Genron NPO seeks to uphold and revitalize the rules-based international order, multilateralism, and democratic values by fostering dialogue among key global actors and generating new ideas and solutions through informed debate. We also strive to shape international discourse in pursuit of solutions to the world's most pressing challenges.



## Pursuing active debate to tackle the issues head-on as stakeholders

Japan is now at an impasse and faces an uncertain future. The rapidly aging population and mounting government debt are issues that require urgent action. Nevertheless, full-fledged action has yet to be taken to deal with these risk factors.

Furthermore, the future of the surrounding Northeast Asian region is becoming increasingly uncertain amid increasing geopolitical competition between superpowers, issues surrounding the Taiwan strait, and North Korea's nuclear development program. The greater international order is also becoming unstable with the worsening of various global issues, a surge in populism, and the distrust of democracy that is spreading in many advanced countries.

This will continue as long as people stand aside and act only as onlookers. Everyone must address the issues that Japan and the rest of the world face as stakeholders, and search for solutions through discussion and voicing of opinions. Doing so will bring people with the same commitment together, thereby creating dynamic momentum and generating healthy public opinions that can produce solutions. This is why I attach the utmost importance to the power of sound public opinion.

We at The Genron NPO are determined to continue our efforts to address issues in Japan and the surrounding world by creating a venue for genuine debate where all can contribute as stakeholders.

As founder and president of The Genron NPO, Kudo regularly evaluates the election pledges of political parties and the performance of those elected. He established the Tokyo-Beijing Forum and the Japan-South Korea Future Dialogue and has continued to host these influential high-level track II dialogues for the past two decades. Kudo launched the Tokyo Conference in 2017 with the aim of developing solutions for common global challenges, preserving democracy, and calling for collective action.

## Establishment of The Genron NPO

The Genron NPO was established in 2001, when the administration of Junichiro Koizumi came to power. Yasushi Kudo, then editor of a monthly opinion magazine called *Ronso: Toyo Keizai*, felt that Japanese politics would remain stagnant unless the voters become stronger. He believed in the need for a non-profit venue for high-quality, participation-style debate, which could provide voters with the information they needed to enable them to make their own decisions about politics and their future.

Kudo felt that society faced a crisis due to the conventional media's "barren and detached criticism," as if they were reporting the news as bystanders. He described it as a "recession of public discourse," and emphasized the importance of addressing the mountain of issues Japan faces at home and abroad through serious debate. Since then, The Genron NPO has expanded the scope of its activities from the evaluation of key domestic policies and solutions to Asian and global issues.



## A non-profit, nonpartisan, and independent think tank

The Genron NPO is a non-profit think tank that acts independently and impartially, free from government involvement or the influence of other special interests. In order to maintain its independence and impartiality, The Genron NPO developed an internal evaluation system designed to assess its non-political and non-religious position based on standards set by the Internal Revenue Service (IRS) in the United States, and it was the first organization in Japan to implement such a system. The Genron NPO conducts its self-evaluation annually and releases the findings to the public. Furthermore, The Genron NPO's auditors evaluate the self-evaluation process, the content assessed, and the results. The Genron NPO makes its self-evaluation results and outside evaluations openly available to the general public. This information allows citizens to determine whether The Genron NPO's activities are in the public interest.

### Internal Assessment at The Genron NPO

The Genron NPO's internal assessment begins with an objective evaluation of the organization to ensure that Genron remains both non-partisan and non-religious. Once complete, the five Content Evaluation Criteria (see \* below) are used to assess any items that are in danger of drifting towards political or religious bias. These two evaluation standards form the basis for all Genron activities, and the results are publicly announced alongside the opinions of two external auditors. Our evaluation for 2023 saw The Genron NPO again successfully meet all of its targets in maintaining non-political and non-religious bias for all items in the assessment.

\* Each item:

1. Must have a clear purpose
2. Must have a clear position
3. Must have a clear target
4. Must have clearly laid-out methodology
5. Must maintain good governance and transparency in policy-making

Conventional ideas about order are becoming increasingly distorted in various fields around the world, and conflict has begun to win out over cooperation. # Tackling global issues

## Tokyo Conference

### Ten think tanks from around the world gather to discuss global issues at the annual Tokyo Conference

Freedom and democracy became the foundation upon which the global order was built in the aftermath of the Second World War, but these principles have been subject to increasingly intense challenges in recent years. Motivated by this sense of urgency, The Genron NPO launched the Tokyo Conference in March 2017, as an annual high-level, cross-cutting discussion platform that brings representatives from think tanks in ten leading democracies to Tokyo to discuss pressing global issues. These prominent think tanks are based in the G7 member states, Brazil, India, and Indonesia – nations with shared values that all advocate for the rules-based order, multilateralism, democracy, and individual freedoms as the basis of international cooperation.

One of the goals of the Tokyo Conference is to encourage cooperation and develop rules and solutions that address common global agendas. These are used to propose policies that are disseminated throughout Japan and the world at large. It has welcomed more than 100 speakers from roughly 40 countries, including head-of-state and senior officials of international institutions and influential experts in various fields.

A new Advisory Council was convened in 2023. Members of the Advisory Council help to improve the conference and to develop a supporting network through advising on strategic planning and operations. The thirteen distinguished individuals who make up the Council are primarily top business executives in Japan. In addition, former Prime Minister Fumio Kishida has been a strong supporter of this conference since its inception and now serves as Chief Advisor of the conference.

The Tokyo Conference has come to be recognized by the world's think tanks as one of the more important conferences in the international policy epistemic community, alongside such events as the Raisina Dialogue

(India) and the Munich Security Conference (Germany).

The Tokyo Conference has received high praise for its status as a Japan-based international forum open to the public, and for providing concrete proposals based on the discussions held.

## Disseminating opinions to the world as Japan's leading internationally recognized think tank

In 2012, The Genron NPO was selected as the only institution from Japan to participate in the Council of Councils (CoC), an international think tank network comprised of the world's leading think tanks. Originally proposed by the U.S. Council of Foreign Relations (CFR), the CoC serves as an arena for think tanks to hold dialogues on issues related to global governance and international cooperation.

The Genron NPO came to be selected by the CoC for its continued efforts to hold independent, neutral discussions that represent citizens, exemplified by the annual Tokyo-Beijing Forum which has been held every year since 2005, and for creating an innovative civil diplomacy model through international dialogues interlinked with public opinion polls. The Genron NPO attempts to convey the various opinions heard in Japan to the world and has held active discussions to solve global issues on various international platforms.

# Civil diplomacy to build peace in Northeast Asia

## Asia Peace Conference

### Multilateral dialogue for rule-making for a peaceful order in Northeast Asia

Northeast Asia remains fraught with potential flashpoints. In recent years, the deepening strategic rift between the United States and China has further exacerbated regional insecurity. Despite these mounting risks, Northeast Asia lacks formal mechanisms to prevent conflict or accidental military clashes, and there is no established multilateral framework for regional dialogue.

In response to this critical gap, The Genron NPO launched the Asia Peace Conference (APC) in January 2020. The forum brings together 20 distinguished individuals engaged in foreign policy and security from Japan, the United States, China, and South Korea. As a Track 2 dialogue initiative driven by the private sector, the APC was jointly founded by members from these four countries to explore principles for peace, as well as a code of conduct and necessary rules to foster lasting stability. Its overarching objective is the establishment of a regional framework for conflict avoidance and sustainable peacebuilding. At its inception, the APC committed to

conducting an annual assessment of security risks in Northeast Asia and to developing multilateral accident-prevention agreements. These efforts are grounded in three core principles: anti-war, opposition to hegemony, and adherence to the rule of law. In a region where no formal multilateral security dialogue currently exists, this initiative represents a historic and significant step in advancing private-sector diplomacy. Since 2021, in addition to the four-country dialogue, the APC has published an annual expert report reflecting the perspectives of approximately 200 security and foreign policy experts from Japan, China, South Korea, and the United States. The report identifies and analyzes the top ten security risks facing Northeast Asia in the coming year, thereby providing a vital reference point for future regional cooperation.



## Japan-U.S. Dialogue

### Fostering stronger Japan-US relations

The results of joint U.S.-Japan opinion polls conducted by The Genron NPO in 2017, when the Trump Administration first took power, made it clear that while the U.S. and Japan are allies, there is an insufficient level of understanding between the peoples of the two countries, and the relationship between the U.S. and Japan is vulnerable. It is for these reasons that we launched the citizen-based Japan-U.S. Dialogue in 2017, as a means for the two countries to cooperate on various issues, and also to strengthen the U.S.-Japan relationship through the support and understanding of the citizens of both countries. The first issue in which cooperation is needed is the effort to ensure

a lasting peace in Northeast Asia. A number of points were discussed during the 2017 Japan-U.S. Dialogue, including shared principles for peace in the U.S.-Japan-South Korea alliance centered on the U.S., and the North Korean nuclear issue, both of which must be considered in the process of building peace in Northeast Asia. Since then, leading security and foreign policy experts from Japan and the U.S. have engaged in heated debate on the future of the U.S.-China economic conflict, the influence the conflict will have on security in the region, the denuclearization of North Korea, and the overall peace process on the Korean Peninsula.

## A 20-year-old venue for track 1.5 diplomacy that has had a profound impact on the policymaking processes in both Japan and China

The Genron NPO launched the “Tokyo-Beijing Forum” as a bilateral track II dialogue in 2005, when Japan-China relations were at their worst. This forum has met once a year in the 20 years, and it has been the subject of broad media coverage as it has developed into an influential venue for dialogue.

In 2006, Shinzo Abe emphasized the importance of Japan-China relations in an address he gave to this forum. Two months later, he made a surprise visit to Beijing as prime minister of Japan, and the bilateral relationship significantly improved. Additionally, despite increasing tension over territorial disagreements in 2013, the 9th Tokyo-Beijing Forum adopted a “No-War Pledge,” exemplifying the firm determination of Japan and China to solve issues through dialogue, no matter the situation.

Current Prime Minister Shigeru Ishiba and three former Japanese Prime Ministers participated in the 20th Tokyo-Beijing Forum in 2024, along with more than 20 ministerial-level Chinese panelists. On this occasion, the two organizers signed an agreement to continue this forum for the next decade, marking the beginning of a new chapter.

### Joint Japan-China public opinion poll

The Genron NPO annually has conducted opinion polls in Japan and China for two decades, something no other organization has achieved. The findings have been utilized by many researchers, thinktanks and research institutes around the world.



### Japan-Korea Future Dialogue

## The open dialogue aimed at improving bilateral relationship

The Genron NPO established the “Japan-Korea Future Dialogue” in partnership with the East Asia Institute (EAI), an independent think tank based in South Korea, in 2013, with the aim of design a new bilateral relationship by fostering open dialogue between Japan and South Korea on historical issues and obstacles to peace in Northeast Asia. The dialogue has been held annually, alternating between Tokyo and Seoul.

Over the past decade, the Japan-Korea Future Dialogue has developed into a major platform for dialogue, bringing together policymakers and representatives from multiple sectors, and attracting hundreds of participants each year. The two organizations have also conducted a joint public opinion survey every year in order to better understand public perceptions and attitudes toward bilateral and regional challenges.



# Designing the future of democracy and civil society

## Democracy Dialogue

### Fully inspecting the democratic mechanisms of Japan and offering proposals for improvement

The Genron NPO conducts public surveys in collaboration with think tanks around the world. Those surveys have revealed that many people in Japan feel unrepresented by their politicians, and that they have low expectations regarding problem resolution abilities of politicians and their political parties. In addition, there is increasing skepticism towards democracy itself, particularly among young people. This trend can be seen around the world, where populism continues to spread.

In the fall of 2019, The Genron NPO worked with ten Japanese political scientists to establish a strategic planning team that would help strengthen Japanese democracy. We have begun conducting a comprehensive examination of the mechanisms of Japanese democracy, from the National Diet and the political parties to the media and civil society.

We later began inviting experts who are working to restore democracy worldwide to take part, such as Anders Fogh Rasmussen,

former Prime Minister of Denmark and 12th Secretary General of NATO, as well as young political leaders from ASEAN countries. Our discussions revolve around how to tackle the difficulties faced by democracy: what lies behind the deteriorating trust in democracy in countries across the globe? What reforms must be made to regain that trust and make democracy more resilient? Since 2023, we have focused on the theme of restoring democracy, and we are now working with experts around the world to create a plan to reform democracy within Japan.



## The “Excellent NPO” Award & Standards

### Japan’s first ever self-evaluation standards for NPOs

Most Japanese NPOs lack strong problem-solving skill and organizational abilities. As a result, many NPOs are unable to work as a truly reliable players in civil society for citizens hoping to independently resolve issues. Recognizing this problem, we examined the current state of civil society and the activities of not-for-profit organizations. This enabled us to identify three areas that mark an NPO as being of particularly high ability: problem-solving abilities, organizational sustainability, and citizen participation. We define organizations satisfying these standards as “Excellent NPOs.” Next, we developed and publicized Japan’s first tool for NPOs to self-assess their organizations: the Excellent NPO Evaluation Standards, and the inaugural Excellent NPO Award was presented in 2012 to promote discussion of issues related to civil society in Japan.



# Policy debates, open forums, and outreach

## Genron Forum

### Citizens are given the opportunity to engage in in-depth discussions on a wide range of issues throughout the year

Since 2001, The Genron NPO has served as a forum for discussion among members of civic society, through which we encourage Japanese people to think about various domestic and international issues on their own. Throughout the year, we hold more than fifty forums to give citizens the opportunity to reflect upon a great variety of issues, from global problems such as infectious disease, climate change, and abnormal weather events, to issues more closely connected to Japan such as peace in Asia. The Genron NPO and its President Yasushi Kudo have also opened a YouTube channel that hosts videos offering commentary on forums, current events, and more.

As the use of the internet and social media spreads, people are being increasingly exposed to emotion-based arguments designed to exploit their fears. This means that we all need the ability to think about issues on our own, and to learn how to tackle such issues together. The Genron forums offer

people that opportunity.

In addition, The Genron NPO holds two types of monthly workshops—one for donors and one for individual members—focusing on pressing global issues and challenges in the Northeast Asian region. These closed-door workshop invite a leading expert or a policy maker to provide in-depth briefings and facilitate candid, substantive exchanges on urgent topics in a confidential setting.

## Tokyo-Beijing Forum Speakers Affirm Bilateral Ties; Foreign Minister Iwaya Wishes To Visit China Soon



In his address, Foreign Minister Takeshi Iwaya touched on the worsening sentiment toward Japan in China as shown in a recent Japan-China joint public opinion poll and said, "I once again felt the importance of further deepening mutual understanding." He also expressed his desire to visit China at an early date, saying, "We must strengthen our communication."

Chinese Foreign Minister Wang Yi, a member of the Politburo of the Chinese Communist Party, said in a video message, "We'd like to make joint efforts to promote the development of the bilateral relationship."

During the plenary session, panelists including Shota Yachi, former secretary general of the National Security Secretariat, and Yi Gang, former governor of China's central bank, the People's Bank of China, discussed topics including the state of international order centering around the United Nations, and measures for cooperation between Japan and China in the financial sector.

“大国による「力の秩序」が今後の国際社会の中心的な特徴に”…回答6割超える 国際情勢アンケート

日本の民間団体「言論NPO」が4日、世界の主要なシンクタンクなどに行った国際情勢に関するアンケート結果を公表しました。大筋による「力の秩序」が一時的なものでなく、今後の国際社会の中心的な特徴になるとの回答が前を越えました。

日本の民間団体「言論NPO」が4日、都内で発表したのは、世界36のシンクタンクの協力で26か国293人の専門家にに行ったアンケートの結果で、アメリカとイスラエルによるイラン攻撃の前に実施されたものです。

それによりますと、アメリカを含む大国による「力の秩序」は一時的な現象かとの問いに対しては、62.1%が「今後の国際社会の中心的な特徴になる」と回答。常態化するとの方が、「一時的なもの」とした11.9%を大きく上回りました。

また、大国による「力の秩序」が今後の中心的特徴になると考えた専門家に、その先の世界像について質問したところ、53.9%が「アメリカだけでなく、他の大国の勢力も重なり形成される。世界は多極化する」と回答。一方で、「米中2極体制」との予測は11.4%、「アメリカ主導の世界」は2%にとどまり、半数以上が世界の多極化を予想していることが分かりました。

一方、「2050年頃、国際社会を主導している国・地域」についての問いには、「アメリカ」が28.2%、「中国」が28.5%、「アメリカと中国」が29.5%と、世界の中心が米中に変化しているとの認識が示されました。

北東アジア 懸念は北朝鮮

非営利団体「言論NPO」(工藤泰志代表)は30日、日米中韓の4カ国の専門家へのアンケート調査に基づく「北東アジアの平和を脅かす10のリスク」を発表した。朝鮮半島情勢や米中対立に加え、11月の米大統領選の影響を懸念する声もあった。調査は毎年実施。今回は4カ国の外交や安全保障の専門家計166人が回答した。紛争発生を要因と、可能性や影響の大きさを踏まえて採点してもらい、順位付けした。

言論NPO 日米中韓の専門家調査

1位は「北朝鮮が核保有国として存在し、ミサイル発射などの挑発的な行動を繰り返していること」だった。そのほか、6位に「日米中韓と中国、ロシア、北朝鮮の『新冷戦』の構造、10位に「ロシアと北朝鮮の『包括的戦略パートナーシップ条約』」が入るなど、朝鮮半島情勢への懸念が目立った。また、2位には「サイバー攻撃の日増し」、6位(同率)には「経済的安否障壁」が入り、米中関係については、軍事面以外でも対立の懸念が広がっていることがわかる。9位には「米大統領選結果が北東アジアに及ぼす影響が及ぼすことが不透明なこと」が入った。特に韓国が指摘しているのは、トランプ前大統領が選出された場合、独自の北朝鮮外交を展開することを不承認している。調査の詳細は言論NPOホームページ (https://www.genronnpo.net/)。言論NPOは、今回の調査結果を踏まえ、4日に東京都内で、4カ国の専門家を集めて北東アジア地域の平和を話し合う「アジア平和会議」を開催する。(松倉佑輔)

Tokyo-Beijing forum aims to warm chilly relations



KYOTO, JPN — The Tokyo-Beijing Forum was held in person this week in Japan for the first time since it went virtual during the COVID-19 pandemic.

During the two-day forum from December 4 through 5, officials from Japan and China expressed hopes to warm their frosty relations.

Analysts pointed to China sending a higher-level delegation than at past forums as a sign that Beijing wants closer trade ties with Japan.

Amid worsening public sentiment, the Tokyo-Beijing Forum wrapped up on Dec. 5 with experts adopting a declaration to promote government dialogue and people-to-people exchanges.

Chinese participants repeatedly emphasized that “now is a critical time to advance relations,” and both sides agreed on the importance of talks between their leaders.

Around 300 former Cabinet ministers and former officials in diplomacy and defense from the two countries discussed security and responses to global conflicts. The forum in Tokyo was organized by Japan’s Genron NPO and the China International Communications Group.

During the two days of discussions, Chinese participants stressed the significance of improving Japan-China relations at this vital time.
